




Gender-related SDG indicators (88 indicators)

Many of the 247 SDG indicators require disaggregation by sex or relate to gender issues, such as maternal health and violence against women and girls. There are 88 gender-related indicators in the SDG and the table below summarizes which indicators are gender-related under each goal.
